The Columbiana County Commissioners support the Columbiana County Park District's application for the 2010 Clean Ohio Recreational Trails Grant program.

The application is for the cost of engineering in the amount of \$68,473. The Columbiana County Park District has received a Federal Transportation Grant award for construction of an additional 1.46 miles of the Little Beaver Creek Greenway Trail. The cost of engineering is not included in the award, therefore, the request for a Clean Ohio Recreational Trails Grant for the additional expense of engineering.

The completion of this construction will further enhance the ability to meet up with the Mahoning County section of the Great Ohio Lake-to-River Greenway Trail at S.R. 14 in Washingtonville.

RESOLUTION NO. #3-2010

COUNTY OF COLUMBIANA, OHIO

DESIGNATING THE COLUMBIANA COUNTY RECOVERY ZONE FOR PURPOSES OF SECTIONS 1400U-1, 1400U-2 AND 1400U-3 OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED

WHEREAS, Section 1400U-1 of the Internal Revenue Code of 1986, as amended(the "Code") authorizes the County of Columbiana (the "County") to designate a "recovery zone" for purposes of issuing (a) Recovery Zone Economic Development Bonds under Section 1400U-2 of the Code and (b) Recovery Zone Facility Bonds under Section1400U-3 of the Code; and

WHEREAS, the term "recovery zone" means (a) any area designated by the County as having significant poverty, unemployment, rate of home foreclosures or general distress, (b) any area designated by the County as economically distressed by reason of the closure or realignment of a military installation pursuant to the Defense Base Closure and Realignment Act of 1990, and (c) any area for which a designation as an empowerment zone or a renewal community

WHEREAS, the entirety of Columbiana County qualifies for such designation by reason of, among other things, its high unemployment rate and general distress;

NOW, THEREFORE, be it resolved by the Board of County Commissioners of the County of Columbiana that:

Section 1. The County's "recovery zone" for purposes of Section 1400U-1400U-2 and 1400U-3 of the Code is hereby designated to be the entire area within the corporate boundaries of Columbiana County.

Section 2. This Board hereby finds that the "recovery zone" described in Section1 hereof meets the requirements of Section 1400U-1 of the Code, in that the area therein is an area having significant poverty, unemployment, rate of home foreclosures or general distress. Section 3. It is found and determined that all formal actions of this board of county commissioners concerning and relating to the adoption of this resolution were adopted in an open meeting of this board of county commissioners and that all deliberations of this board of county commissioners resulting in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

I had arrived here in this room on schedule, offering a prayer as directed, yet always felt out of touch with the work to which each of you had been called to and elected for. My personal experience offered me nothing; no possible notion of the complexities nor the magnitude of the position of commissioner, or any other form of local government for that matter. I wanted to know; I felt it was my responsibility to know how any community into which I enter to work and/or to live operates and meets the needs of its citizens.

I reservedly asked Penny in December if I could shadow her for the day. I set it out there never expecting her to immediately, after the Christmas break, pick up on my request and fit me into her already very busy schedule. I was honored, yet I did not expect to be breaking ground. No one had ever done this before. On numerous occasions last Thursday, we talked about a critical educational piece that is missing for the young people of most communities. Penny had already had some thoughts about how to bridge the educational gap, but ran out of time. I would encourage you all, to keep at it. Continue to offer connective tissue to our young people to bring an understanding and an appreciation of the work of civil servants.
