A Resolution Authorizing the Execution of a certain Economic Development Revolving Loan Fund Administration Agreement, effective January 1, 2021 through December 31, 2023.

WHEREAS, Columbiana County has been determined to be an eligible recipient of CDBG funds and has been awarded CDBG funds for eligible activities that may generate Program Income; and

WHEREAS, Columbiana County has lawfully established an Economic Development Revolving Loan Fund (EDRLF); and

WHEREAS, Said EDRLF may be used to aggregate and spend Economic Development Program Income on projects determined by the County to be important for economic development by either encouraging the expansion and stability of the economic base of the county, or by encouraging increased employment opportunities in the county, particularly for low- and moderate-income persons in the county; and

WHEREAS, Columbiana County wishes to continue to administer said EDRLF; and

WHEREAS, The State of Ohio requires administrators of EDRLFs to execute an Economic Development Loan Fund Administration Agreement in the form of the attached document; and

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COLUMBIANA COUNTY, OHIO:

- 1. That the Board of County Commissioners does hereby approve the Economic Development Loan Fund Administration Agreement as attached; and
