**RESOLUTION NUMBER 52-2021**

**A RESOLUTION ADOPTING A COUNTY INDIGENT DEFENSE FEE RECOUPMENT POLICY.**

Motion by Commissioner Paparodis, seconded by Commissioner Weigle, to adopt the following resolution:

**WHEREAS**, the Ohio Public Defender has adopted regulations for the appointment of counsel for the indigent; and

**WHEREAS**, pursuant to Ohio Administrative Code 120-1-05, each county must adopt a plan to recoup all or part of the expense of appointing counsel to an indigent person who meets certain income guidelines; and

**WHEREAS**, the Columbiana County Common Pleas Court, General, Probate, and Juvenile Divisions and the Columbiana County Municipal Court are required make the appointment of counsel in accordance with the rules established by the Ohio Public Defender Commission and the Ohio Public Defender to enable this County to receive reimbursement from the State for all or part of the indigent defense costs; and

**WHEREAS**, when assigning counsel to indigent parties, the Columbiana County Common Pleas Court, General, Probate, and Juvenile Divisions and the Columbiana County Municipal Court shall, in accordance with Ohio Administrative Code 120-1-03, order that a part of counsel fees be repaid to the County where the appointment is made if the indigent person falls within the income guidelines set forth in Ohio Administrative Code 120-1-05; and

**WHEREAS**, the Board desires to adopt a policy to recoup all or part of the expense of appointing counsel to an indigent person who falls within the income guidelines set forth in Ohio Administrative.

**NOW THEREFORE**, be it resolved by the Board of Commissioners of Columbiana County, Ohio, that:

1. The Board hereby adopts the Columbiana County Indigent Defense Fee Recoupment Policy contained in the attached Exhibit "A".
2. This Resolution and the attached Exhibit "A" shall be applicable to all appointments of assigned counsel by the Courts of appropriate jurisdiction effective October 1, 2021 and thereafter.
