COMMITTEE REPORTS:

Commissioner Halleck reflected on 2021 as a good year for the county as revenue was higher than projected as was for other counties in Ohio. In 2021, we have accomplished many things, one being the rehabilitation of part of the old MSJ; our bond rating was up, and our debt was the lowest in many years; the DJFS building debt was paid down to about \$6million; the jail debt was paid for in 2021. For 2022, Commissioner Papanodis will oversee the additional MSJ project that will allow for more segregation, due to COVID possibilities, and will allow for 35-40 cells for women. The Commissioners are still in discussions, but the county needs a sizeable storage building that will allow each department their own space; the basement of the jail currently houses storage items and is running out of space as it was not intended for this purpose. Commissioner Weigle is heading this project.
