Commissioner Halleck added there are a lot of jobs available if people want to work. He stated he has been in contact with ODNR regarding a dam issue, going back and forth to remedy the problem. Pete Conkle of the Soil and Water District offered help if needed. Commissioner Halleck confirmed with Commissioner Paparodis that the plans for the jail are about ready, as the state has approved them for the project.

RE: ADOPT RESOLUTION #28-2022, ARPA EXPENSES AND CERTIFICATION

Commissioner Halleck explained a letter was received from the Mayor of East Liverpool asking for a \$150,000 contribution to remedy some of the blight problems in East Liverpool. As reported by the news, Lt. Gov. Husted announced the funding of 1.2 million to the City of East Liverpool to help tear down the former East Liverpool School Building. Commissioner Halleck believes the Ohio River is one of the Greatest Assets to our county.
