Mayor Dickey of Salem questioned the Board if they have a remedy or an alternative plan in place regarding the animal nuisance that exists in the county. Commissioner Halleck stated our county pound is funded by dog license fees and can only accept dogs. We do not have a plan in the works and stated the city may have to subsidize the Humane Society.

Ms. Bonnie Landsberger spoke on the fact that humans do not have services in this county and the homeless are living on the streets. There is a problem with mental health issues that are not addressed. Commissioner Halleck sympathizes with her statements and unfortunately, as the same in other counties in the state, it is a large ongoing serious problem. He stated in reviewing the county resources with over 300 line items, there are two that have the largest cash balances that we have no control over as they have their own board. Ms. Landsberger said this needs to be talked about and we can't keep it behind closed doors. Commissioner Paparodis stated no one has extra resources and even the people that get help, some aren't successful. There wasn't a formal suggestion to make this better, but Commissioner Weigle stated they are looking at reopening the Residential Treatment Center (RTC) which is multi-county, to help with foster care individuals so they don't have to be transported out of the state. Commissioner Halleck thanked her for her comments and said some people come here looking for problems and we try to look for solutions.

Mr. John Williams spoke up regarding the public records request he sent to our office, particularly regarding the Alliance Rodman Public Library and the funds spent there. Commissioner Halleck tried to explain the expenses, with interruption by Mr. Williams, and finally said the books have been audited and adjourned the Commissioners regular meeting.
