RE: PUBLIC HEARING - 2025 COUNTY TAX BUDGET

SOIL & WATER 2025 BUDGET REQUEST: Mr. Pete Conkle and Mr. Duane Nickel presented reports and information regarding the Soil and Water Conservation District and explained their budget needs in asking for additional money. They explained the H2Ohio project that Governor Dewin adopted statewide. They are requesting funds to provide an outreach and technical assistant to benefit farmers. They continue to work on obtaining grant money and receive a state match from monies received from the County. Commissioner Halleck appreciates all they do, and stated they shall have further discussion on this.

PARKS DISTRICT 2025 BUDGET REQUEST: Ms. Eileen Dray Bardon presented their 2025 proposed budget report stating they have been operating on the gas lease money and are down to bare bones. They have tried three levies, all failed, and have another levy for the fall ballot. If that fails, she proposes to just maintain what they have with one part time (20 hours) and two seasonal maintenance people.

VETERANS 2025 BUDGET REQUEST: Commissioner Halleck thanked the veterans in attendance for their service. Ms. Debra Smith presented information on the Veterans Service Commission Budget request for 2025 explaining how many veterans they service in the county, via transports to appointments, entitlement to benefits, temporary financial assistance, stating inflation has elevated the need for financial assistance, especially for food. They have plans to purchase a new transport van and stated most travel destinations are Cleveland putting excess miles on their current vehicles. They are asking for the full budget of \$1,234,600. Commissioner Halleck questioned what the burn pits are, and Debra Smith explained its where everything from trash, computers, body parts, etc. are burned and those in the Gulf War forward that can prove toxic chemical exposure, experience symptoms can be eligible for medical services.
